ROAD: MR. BURNETT STATED HE HAD BEEN BUILDING UP THE EDGES OF LOWER GRATIS ROAD. TRUCKS HAVE BEEN RUNNING OFF THE EDGE OF THE ROAD, BREAKING THE ROAD AWAY. HE HAS ALSO BEEN KEEPING UP WITH THE MOWING. MR. BURNETT INFORMED THE TRUSTEES HE HAS TURNED IN THE PAPERWORK TO RICK SPLAWINSKI FOR PARTNERSHIP POOL REIMBURSEMENT FOR THE OVERLAY ON EAGLE ROAD. MR. SPLAWINSKI SAID IT WOULD BE A WHILE BEFORE REIMBURSEMENT WOULD BE ISSUED. MR. BURNETT STATED HE HAS FILED THE PAPERWORK FOR POSSIBLE REIMBURSEMENT OF SALT FUNDS FROM MORTON AND CARGILL. MR. MRS. JOHNSON ASKED IF WE HAD ENOUGH SALT. MR. BURNETT RESPONDED BY SAYING YES, THAT HE HAS CONTACTED CONSOLIDATED GRAIN WHO DELIVERS OUR SALT. WE HAVE 175 TONS LINED UP FOR THIS WINTER. MR. BURNETT STATED THE APPLICATION FOR THE HAVERMALE PHASE I PROJECT HAS BEEN FILED WITH THE OPWC. HE HAS NOT HEARD ANYTHING YET. MRS. JOHNSON ASKED IF MR. BURNETT HAS HEARD ANYTHING ABOUT LOWERING THE SPEED LIMIT ON HAVERMALE RD., TO WHICH MR. BURNETT SAID, NO. DISCUSSION FOLLOWED. MR. BURNETT PLANS ON USING SOME OF THE STONE WHICH IS BEING STORED AT THE PARK TO FILL IN SOME OF THE BAD SPOTS ON FORT ANTHONY ROAD, AS WELL AS FINISH UP THE MOWING FOR THIS YEAR. MRS. JOHNSON ASKED IF MR. BURNETT HAS SPOKEN WITH THE LANDOWNERS REGARDING THE FENCING ON LOWER GRATIS ROAD. MR. BURNETT SAID NO, HE HAS NOT HAD A CHANCE TO DO THAT YET. MR. MR. GILLMAN MADE A MOTION TO APPROVE RESOLUTION 2015-19, SECONDED BY MR. DEVILBISS. Vote: MRS. JOHNSON – YES MR. DEVILBISS – YES MR. GILLMAN – YES MOTION PASSED. MRS. WINKLER INFORMED THE TRUSTEES SHE AND MRS. JOHNSON WENT TO U.S. BANK TO REVIEW THE CONTENTS IN THE LOCK BOX. THE BOX CONTAINED OLD PAPERS, DEEDS TO THE PROPERTIES OWNED BY JACKSON TOWNSHIP, AND THE COMBINATION TO THE OLD SAFE. MRS. JOHNSON AND MRS. GILLMAN INFORMED THE TRUSTEES THE WATER BOARD IS WORKING WITH AN INDEPENDENT LAWYER TO RE-WORD SOME OF THE LANGUAGE IN THE PAPERWORK REGARDING THE DISSOLVING OF THE WATER BOARD AND PAYING OUTSTANDING LOANS.MR. GILLMAN SAID HE WOULD ALSO BE SPEAKING WITH MR. KETTER TO SEE IF HE CAN HELP.

TRUSTEES:

MRS. JOHNSON: MRS. JOHNSON STATED SHE EMAILED A COPY OF THE TECHINOLOGY POLICY SHE RECEIVED FROM MIKE DOWDEN TO THE TRUSTEES, AND PLACED A COPY ON THE TRUSTEE DESK FOR OTHER TRUSTEES TO REVIEW. MRS. JOHNSON STATED SHE WOULD LIKE EVERYONE'S THOUGHTS AND INPUT REGARDING THIS POLICY. IF ANYONE WANTED TO EDIT THE POLICY FEEL FREE TO DO SO. MRS. JOHNSON FEELS ONE PERSON SHOULD BE THE CONTACT FOR ANY INFORMATION GOING ON THE WEBSITE. DISCUSSION FOLLOWED. MRS. JOHNSON ATTENDED THE SOLID WASTE MEETING A COUPLE OF WEEKS AGO. MRS. JOHNSON IMMEDIATELY GAVE MRS. MICHAEL THE INFORMATION REGARDING THE TIRE BUY BACK PROGRAM WHICH IS NOW POSTED. THE BUY BACK IS AT MONTGOMERY COUNTY SOLID WASTE. TIRES WILL BE BOUGHT FOR \$2.00 @ TIRE. THEY WILL NOT TAKE LARGE TIRES - ONLY VEHICLE TIRES. MRS. JOHNSON INFORMED THE TRUSTEES THERE IS A BUY RECYCLED GRANT. APPLICATIONS ARE ONLINE AND ARE DUE BY OCTOBER 30TH. THIS GRANT IS FOR NON-PROFIT AND SCHOOLS. MRS. JOHNSON WAS THINKING THE PARK WOULD FALL UNDER "NON-PROFIT". THE PERSON IN CHARGE OF THIS GRANT IS BARB ASBERRY. MRS. SCHADE COMMENTED SHE HAS WORKED WITH MS. ASBERRY ON OTHER GRANTS. DISCUSSION FOLLOWED. MRS. JOHNSON ASKED MRS. SCHADE IF SHE WOULD CONTACT MS. ASBERRY TO SEE IF THE PARK WOULD QUALIFY FOR THIS GRANT TO WHICH MRS. SCHADE RESPONDED BY SAYING SHE WOULD CONTACT MS. ASBERRY. MRS. JOHNSON REMINDED THE TRUSTEES THERE IS STILL "GREEN SPACE" MONEY AVAILABLE THROUGH A GRANT FROM THE MONTGOMERY COUNTY SOIL AND WATER CONSERVATION DISTRICT.
