Mr. Izor stated that Debbie Izor did obtain her food service license and has been reimbursed for the costs.

The new chairs for the community center are to be delivered Monday.

Mr. Weller questioned the status of the door to the recycling center. Contact will be made to see if the issue has been corrected.

Mr. Izor stated that the Board needs to discuss the MudCats contract and do something with it in the fall.

He then stated that concessions could use a new chest type freezer.

Mr. Izor stated there was a problem with the restroom lines the weekend of the baseball tournament and Korreect Plumbing had to be called.

Mr. Weller stated that Mr. Edds has talked to him about the well. He is making arrangements to have the well capped at a cost of approximately \$3,000. We do have an extension to get a new line can so it will not have to be done by the end of the month.

Mr. Izor then stated that we need to compensate Mr. Edds for the extra that he has done that is beyond his regular salary. Mr. Weller stated he will talk to him and will also talk to him about getting the pump sent out.

Mr. Izor stated that the MudCats want to retire the jersey number of the boy who lost his life but there are other ways of honoring the young man and the Board needs to have a say and time to think about it, something like a tree or flag pole.

Mr. Cordell stated it would be up to the MudCats if they decide to retire the number.

Mr. Izor stated we may want to look at replanting some of the trees in the park, some have been cut down and some have died.
