1 Year (New Hires) - \$10.00

2 Years - \$10.15

3 Years - \$10.25

4 Years - \$10.35

5 Years and up - \$10.50

Slide Dispatcher - \$8.80

Pool Manager - \$13.50

Assistant Manager - \$11.35 - \$12.00 (at discretion of Manager)

Concession Manager - \$11.50
