Daily Admission \$5.00, 3-4 year olds \$2.50, 2 and under - free, After 5 \$2.50, Seniors 62 and older - free.

2021 Pass Resident and Non-Resident - Single \$50.00, Family of 2 \$80.00, Family of 3 \$110.00, Family of 4 \$135.00

Pool Party - Pass Holder \$200.00, Non-Pass Holder \$230.00

After hours parties will be held from 7:00 p.m. - 9:00 p.m.

Hours of operation - 12:00 Noon - 7:00 p.m.

The board discussed the sinks at the back concession stand.
