# ROAD: Mr. Pohl

• OPWC has announced that they will begin using an online portal called WorksWise starting July 1, 2021. OPWC has asked that only 1 person in each jurisdiction request a user license to create an account. Keep in mind that this single user will be responsible for inputting all OPWC applications and disbursement requests for all projects, etc. Melinda Harry from Kramer & Associates, LLC, currently takes care of all of this for us. We would like to approve the authorization of Melinda Harry as our WorksWise subdivision representative. Mr. Moyer asked if this was so we can do it ourselves? Mr. Pohl stated no it was basically to cut down

on paperwork and the limit the number of emails. If we appointed someone ourselves we would have to get trained and be in charge of everything Ms. Harry does for us now. Mr. Moyer stated he has always enjoyed dealing with Melinda on projects, she is on the ball, we don't have to think about it, and she just does it. - Mr. Moyer stated that the pool has hired 14 workers for the concession stand and he does not understand why there are so many. Mr. Hodson said sometimes there are some that can only work a few times a week. Mr. Moyer has a list of the employees (attached) that the Park has hired.
- Picnic tables have gone from \$568 to \$704/each. Mr. Hodson asked if that was due to shipping costs or what is the increase for? Mr. Moyer said he believes it was an old catalog. Mrs. Hamaker felt that since there was such a large increase in the cost compared to what we approved at our last meeting that we should approve the increase. Mr. DeVilbiss asked what the delivery time was and Mr. Moyer stated he did not know. Mr. Hodson stated that some of the tables now have holes in them. Mr. Pohl would help with the unloading when they are delivered. Mr. Hodson made motion to approve the additional cost for the picnic tables, Mr. DeVilbiss seconded the motion. Motion passed.

- Mr. Moyer stated that in the April 8, 2021, Park Board Minutes they approved the reimbursement to the Village of Farmersville and Jackson Township for the employee's wages used to get the pool ready. Mr. Moyer asked Doug to get that information together.
- Mr. Moyer asked Mr. Hodson if he had an itemized invoice for the \$4800 expense to repair the ball diamond? And was part of that for the pitcher's mound? Mr. Hodson said yes, he had the invoice and pitcher's mound was not caused by pipe installation. Mr. Moyer would like to have an itemized bill for the pitcher's mound.
- There was discussion among the Trustees regarding the sand volleyball courts and the problem with people using the courts and turning on the lights and not paying for the rental of the courts. Mr. Moyer stated that there are machines that will take money so that the lights can be turned on.
- Mr. Moyer asked if Doug has purchased a mower? Mr. Pohl said not yet, they want to buy a zero-turn mower and then possible leave the John Deere at the Park for them to use on the ball diamonds. Mr. Moyer said only if the Park buy it. The Zero-turn mower will be split between the Village, the Park and the Road.
