Mr. Cordell questioned a grant application submitted to Montgomery County that is still showing as active with Mr. Moyer responding that the grant was turned down.

Mr. Izor stated that Derek Shell is getting a quote for the parking lot and repairs to the low spots that need fixed.

Mr. Cordell stated we need to get the driveway to the recycling center sealed at least.

Mr. Moyer added that the driveway has never been sealed and it may not help.

Mr. Izor stated that some additional painting may need to be done in the deep end of the pool and the baby pool also needs to be painted.

The Board discussed the slide, fencing and shade structures.

Mr. Izor stated the port-a-john needs to be removed by the recycling center because it is not being used. After a brief discussion it was determined to send it back and Mr. Izor will call to have it removed.

The Board then briefly discussed the pool with Mrs. Sizemore stating that she feels the minimum age for a lifeguard needs to be changed back to sixteen.

Mr. Izor then discussed an issue with Manager pay and stated there are pros and cons to having a salaried Manager position. He added that from past experience there is no consistency when there are two or more assistant managers.

The Board then discussed closing dates for the pool as most of the schools are going back around August 16th with the exception of Valley View.

Motion by Mr. Izor, second by Mr. Cordell for the last day of operation to be August 15th. We will then be open the weekend of August 21st and 22nd, the weekend of August 28th and 29th and September 4th and 5th. Hours of operation will be 12 Noon - 7. ALL IN FAVOR. MOTION CARRIED.

Mr. Cordell stated the picnic tables are done. He then added that he and Mr. Weller will work on the baseball concession stand permit and sink.
