VISITOR COMMENTS: Mrs. Plymyer stated that she and her husband completed a class put on by the Cemetery Conservators for United Standards. It was held in Moscow, OH. The class was two days and had ten instructors with 54 other students. They learned a great deal and feel more than prepared to continue with the restoration of the headstones at Stiver Cemetery. This past month they reset three more headstones. During their class they learned that when a headstone is broken below the surface it was inadvisable to repair as it would most likely break again due to the stress. William Green's headstone was broken like this, but this headstone still had plenty of room above ground so it was reset, even though it is no longer as tall as the others in the cemetery. Also, at this class they learned that Myrtle is a native plant that is non-evasive but also keeps out invasive plants — so they planted Myrtle inside the fenced area of Abraham Swartzel grave to eliminate the need for mowing and help deter invasive plants.

FIRE: Chief Erisman

- Chief Erisman thanked the Trustees for the help they did with Montgomery County to try and get funding for the new medic. Unfortunately, Chief Erisman was notified last week that Montgomery County would not be able give them any ARP money for this funding. Mr. Moyer stated that the ARP money has tight restrictions so the County is not able to use it towards purchases such as this medic.
- Chief Erisman stated he was also notified that the grant he applied for through FEMA for a new brush truck as also denied.
- Chief Erisman stated they have a portable generator on a trailer, but with the all the lighting on the trucks they no longer need the generator, he has spoken to Mr. Pohl and offered to donate the generator to Jackson Township Road Department to use as necessary. Mr. Pohl stated he was very interested and could use this at his building when/if they lose power. It is a 5000-watt generator. Mr. Pohl will go pick it up from the Fire Department.

POLICE: Mr. Moyer for Chief Schade

- We conducted a special detail at the Community Park for the Valley View Booster Club on Saturday, October 2, 2021. The event was successful and there were no safety nor security issues. There were 30.5 police employee hours used for the event. Chief Schade with 12 hours, Sergeant Bruner with 4.5 hours, Officer Creech with 10 hours, Officer Moore with 3 hours and Officer Steffano with 1.
- We have applied for two Body Worn Camera grants, one state and one federal. The quote for the equipment and cloud storage is approximately \$20,000. There will be a reoccurring annual fee of \$3,000 \$4,000 for cloud storage of the data. Chief Schade will advise on the next steps once we have grand award notification.
- Chief Schade was contacted by the Montgomery County Engineer's Office regarding the intersection of Manning Road and Diamond Mill Road. Thus far, in 2021, we have responded to four crashes there, but they have been either Jefferson or German Township responsibilities.

ROAD: Mr. DeVilbiss for Mr. Pohl

- Road mowing for the year has been completed.
- Black top work on Guntle Rd. and Church St. has been completed.
- Road Dept. is currently working on crack sealing Mile Rd.
- Currently working on a cost estimate for paving Fuls Rd. from Havermale Rd. to Route 35 in New Lebanon. This money is being applied for through the Township Stimulus Program from ODOT.
- Cut trees down on Lower Gratis Rd.
- Chip Seal work is complete on Rhoades Rd. Swartzel Rd. and Lower Gratis Rd. still need to have the loose stone swept.
