Farmersville Fire currently pays \$12 and \$13 for these services.

## ROAD Mr. Pohl

- April 12<sup>th</sup> Mr. Pohl had a meeting with Doug Kramer on Havermale Road regarding the work on Havermale Rd. He still does not have a start date or a bid for this project. He said they are still in a waiting game.
- April 14<sup>th</sup> had a meeting with Greg from Hensley, the company that did the chip seal on Rhoades Rd. and they are going to cap it and touch up before the cap is put on.
- Also, on the 14<sup>th</sup>, we had a tree down on Swartzel Rd. and high water on Anthony Rd. that we had to repair.
- Did some Hydro-Vac for electric and water lines on Havermale. Was not able to find the exact location of the water lines; Jefferson Water Authority said "if you hit them, call us, we will come repair them".
- Replaced pipe on Guntle Rd and ditch work.
- Repaired a pipe on Chicken Bristle Rd.
- Gravel work on Lower Gratis Rd.

- Crack sealed Hemple Rd.
- Mr. Eby is doing the mowing of the roads, park and cemetery.
- Working on repairs at the pool and power washing so Annie, pool manager, can get her inspections completed and pool can open.
- Road Department started their summer hours of four 10-hour days.
- Mr. Moyer stated that he was at the park and the bat wing mower looks like it needs an adjustment as the mowing was not very even. Mr. Pohl said he was aware and they are working on it.
- Mr. DeVilbiss did receive the ball-curve indicator, he is still waiting to receive an official document stating what the legal speeds are in our township – he said for example they do not have the speed limit change to 40 mph on Swartzel. Mr. Pohl said he will have to have Lisa look into it because it was done when Diana, previous Fiscal Officer, was here. Mr. Pohl confirmed they have a count of the signs to be replaced.

# STIVER CEMETERY UPDATE

Jim and I made a sweep of Stiver Cemetery picking up all the winter limb debris to prepare for the new spring time work. The general fencing seems to be in satisfactory shape. There is a row of large trees lining the outside of the north side fence between the cemetery and the cemetery access drive. Unfortunately, most of those trees are dead. There were three large limbs that we hauled over to the side out of the way. Luckily, no headstones were damaged when they fell. Jim and I are concerned that these trees will eventually fall either into or outside of the cemetery. If they fall outside of the cemetery, they will block the road. We wanted to bring your attention to this problem. I spoke with Doug Pohl last week and he graciously said he would look into it to see what could be done.

The myrtle ground cover we planted within the Abraham Swartsel monument area survived the winter and is beginning to spread. There were even a couple of purple flowers that bloomed.

Thank you again to Doug Pohl for bringing out another load of crushed limestone to the cemetery. It is appreciated so very much.

This month, we reset the headstone of Jacob Brown. It was sunken and leaning badly. We never know how these things will progress so we were pleased to find it intact. It now is beautifully installed once again.
