VISITOR COMMENTS: Mr. John McManus, Treasurer for Montgomery County, gave a presentation regarding the services provide especially the ones that most residents are not aware. For instance, they have a program where you can sign up for monthly tax payments, can pay electronically, and residents that are in the risk of foreclosure can contact the treasurer's office to set up a payment plan (this must be done through the treasurer's office in order to avoid foreclosure). Mr. Hauck from Lower Gratis Road respectfully requested assistance in getting culvert repair to the gravel part of Lower Gratis Rd. He stated he has been in contact with Mr. Pohl, Road Superintendent, but nothing has been done. He said the dips and wash outs make it extremely difficult and uncomfortable to drive on. The trustees said they would look into it but that part of the road is difficult to keep in good condition due to the creek flooding.

#### FIRE: Chief Erisman

- Mr. Erisman reminded all that the Annual Barbecue is August 6 with the Church Service starting at 10:00.
- The new medic will now be a 2023 chassis.
- He then asked if the Trustees had any more of the ARPA money to donate to the Fire
  Department for said medic. The trustees allowed Mrs. Kozarec to respond which she stated
  that the remaining funds have already been earmarked for the Road Departments grant
  application for Clayton Rd.

## **POLICE: Sergeant Bruner (for Chief Schade)**

- The new Ford Explorer cruiser is in service, they ordered a keyboard mount for the MDT which should be in anytime. This will complete the cruiser.
- Cruiser 14 has been cleaned and stripped of the decals. All the equipment has been removed.
   We still need to get government plates before it is available for use by our Zoning/Park Administrator.
- We are waiting for the new lightbar to arrive so the new charger can be built and put into service.
- Body worn cameras arrived last week. Chief Schade and Sgt. Bruner had a conference call with Getac (camera mfr) today for the initial set-up and update. We will have training on Friday, July 14. We have asked Mrs. Hamaker to join the training so she will be able to fulfill any public records requests.
- Several fireworks complaints, however everyone seemed to follow the new law.
- Retention bonuses were paid on the last pay period. Sgt. Bruner has asked Mrs. Kozarec to hold
  off on any further payments until the Chief requests another payment and the trustees
  approve/agree to it.
- There was a minor issue with a patron at the bool that believed it was ok to attend under the influence, situation was taken care of without incident.

#### PARK: Mrs. Hamaker

- Nick Lamb has sent a message wanting to possibly do more baseball tournaments at the park, he also would like for the backstop on one of the diamonds to be replaced and also the bathrooms to be updated with new sinks and new toilets. An email was sent to the park committee and I have only gotten one reply. For the tournaments he would like to bring in local food vendors so they could benefit from all the people in town too. After discussion, Mr. Moyer asked to see what was causing the smell in the back bathrooms before any decision is made. In addition, he felt the backstop would be at the cost of the MudCats per our agreement. Mr. Hodson stated he would look into this further.
- The mushroom in the baby pool area is working again. Annie said the kids love it!!
- The deck is stained at the pond and one of the back gates is painted.
- It has been brought to my attention that Baseball is looking at the concession stand at the baseball fields and planning to open it up. Do they have proper permits to open it? Can they even get permits since they are not Farmersville/Jackson Township (the owners of the property)? In the past it was stated that baseball did not want a concession stand. If there is to be a concession stand opened for baseball the township will run it and there will only be prepackaged foods sold there. Once again, Mr. Hodson stated he would look into it but he was told that it was packaged food only. Mrs. Hamaker told him there is a "Blackstone Griddle" with pretzels in bags in the fridge. Mr. Hodson asked if that has been on? And Mrs. Hamaker stated it was not even plugged in last time she checked before finding out that this concession stand was being used without permission.
- Mr. Hodson requested permission for a donation of a fence for field 4 behind the pool. The trustees approved the fence.
