STIVER CEMETERY UPDATE

Thank you to Doug Pohl for the beautiful lawn cutting and trimming at Stiver Cemetery this past week. Not only are the headstones edged neatly but also all the fence lines. Do you think the pioneers who are resting here would ever imagine the care Stiver Cemetery would receive after over 200 years?

Jim and I continue work on the more severely broken headstones.

The headstone of Anna T. Stiver, aged 28, is now complete. Anna was the daughter of Abraham and Elizabeth Swartsel. She married Henry Staver. Henry and Anna had four children. After Anna passed away, Henry married Sarah Sophia Bickle. They had seven children. Henry, first wife Anna, second wife Sarah and at least three of Henry and Sarah's children, Emanuel, Catharine and David are buried in Stiver Cemetery. Anna's headstone was broken into three pieces. The lower section was broken off at ground level. The top two sections were located laying on top of husband Henry's large slotted base. Anna's headstone is mudstone.

The headstone of Elizabeth Smith, aged 52, is now repaired. It was also broken into three sections. The top section was located underground covered by several inches of soil. One of the remaining sections was located nearby and the last section was located in another part of the cemetery. The breaks were not clean and repairing them was time consuming. It is marble that will clean up beautifully. Elizabeth's husband Henry and their daughter Elizabeth are also buried in Stiver Cemetery.

If you recall, there was a storm last April that caused a large tree to fall in the cemetery. And miraculously, only one headstone was hit by the falling tree causing the headstone to be knocked out of it's setting. This headstone belongs to Infint* Daughter Biers, aged 5 hours. Jim and I had previously reset her headstone on 24 Apr 2021. As I have stated multiple times over the years, Jim and I work tirelessly to reset the headstones in their proper location as much as we are able to determine. When we reset Infint* Daughter Biers' headstone the first time, we reset it where we discovered it. About a year later, we discovered it's matching footstone approximately 8 feet to the north. The footstone was still buried deep surrounded by field stone so there was no question that her headstone was moved over the years, probably by storms for the past two hundred years as it is on the area that slopes southwest. We were distressed at the discovery and vowed to some day move the headstone to the footstone location. So as Jim put it, it was "no doubt the hand of God" when the storm hit this past spring. Infint* Daughter Biers' headstone was the only headstone affected. It was the only headstone to be popped out of the ground. And it did not receive any damage. So now Infint* Daughter Biers is reset once again but at the proper location.

We would like to request that another safety mirror be placed across from the cemetery drive on Preble County Line Road to replace the one that is missing.
