FIRE: Chief Erisman

- The Marcs Grant is open and Chief Erisman stated since they are private they will need us to sign the grant for them; which we have done in the past.
- Chief Erisman stated they have a levy renewal for next year but they are thinking about putting
 an extra levy on to bring in more funds. Mr. Moyer suggested that instead they keep the millage
 the same but do a new levy that would be based on the current property values and would bring
 in more money. Chief Erisman stated that is something that could be done and will have to be
 decided.

POLICE: Sergeant Bruner, written report (for Chief Schade)

- Log splitter was stolen from a barn on Diamond Mill Rd. on 9/12/2023 resident had subjects cut
 wood on his property and were allowing these subjects to use his splitter. Sgt. Bruner stated he
 is familiar with the subjects he had helping and they have a criminal history for theft. No recovery
 at this time.
- Single vehicle crash on Ft. Anthony Rd. (10/6/2023) 19-year-old driver suffered a broken femur. The driver was sliding around on the gravel and struck a tree.
- Booster Club Oktoberfest was on 10/7/2023 and there are no issues to report. Officer Jones from German Twp. police and Sgt. Bruner were there and also had our on-duty car patrol the area as he was able.
- Sgt. Bruner is still working on a candidate for the full-time position.

ROAD: Mr. Pohl

- Mr. Pohl showed pictures of road damage to Chicken Bristle Rd. in front of and entering the Kasperski lane. The damage was caused by a Dozer delivery and them not putting anything down to protect the pavement. The problem is the indentations will hold water and cause the chip seal to be cracked. In addition, when driving over this section of road it feels like you are on "rumble strips" which could be dangerous for motorcycles. Mr. Pohl stated that Sgt. Bruner has reached out to our prosecuting attorney to see what recourse we have.
- Mr. Pohl would like to cancel the previously approved paving on Fuls Rd. due to the talk of a plat, if the plat happens then this paving would be dug up. He would rather move that money to the Clayton Road project between Farmersville-West Carrollton and Manning Rd. (see attached figures). Mr. DeVilbiss motioned to approve the money be moved from Fuls Rd. to Clayton Rd. and Mr. Hodson seconded the motion. Motion Passed.

 - Chip Seal work is finished on Chicken Bristle, Guntle, Walden and Lower Gratis Roads.

Mr. Bruner, the owner of the property at the NW Corner of Havermale and Clayton Rds. stated
he was fine with having us put down rip rap to help with water/erosion. Mr. Hodson made
motion to approve up to \$17,000 for the installation of the rip rap and Mr. DeVilbiss seconded
the motion. Motion passed.

PARK: Mrs. Hamaker from written report

- The slide part is in. The pool is drained, we are looking into what repairs will be needed for the pool. Spear Corp. was in the area and stopped by to look at the pool; they had the idea of sandblasting the whole pool to see where the cracks are and then fixing the cracks and painting the pool. They have not sent a scope of work or quote but the price will most likely be between \$100,000-\$200,000. It is hard to do the quote when they don't know what the sandblasting will show. Shamrock Pools is planning to come out when we get a better look at the one wall of the pool to give us their thoughts on repairing the pool and painting it.
- A Park Committee meeting will be scheduled when Mrs. Hamaker has more details about the pool repairs.
- The Concession Stand and the bathrooms at the pool will be winterized soon.
- The Baseball Concession Stand is now cleaned out; the refrigerator and freezer are unplugged.
- The swans on the pond were damaged but they are now fixed and hopefully keeping away the geese.

- **ZONING:** The Board of Appeals approved the lot split for Lake of the Woods with road frontage on Swartzel Road. A new house will be built there.
