### FIRE: Chief Erisman

- Chief stated the barbeque went well, they received a grant for Farm Days, and the free stage from Moraine was delivered.
- Barn Fire on Preble County Line Rd. was a total loss but the Fire Department were on scene and able to save three other barns.
- August 10, at 2:00 a.m. they had a call that smoke alarms were going off at the old VVJH. Before
  Chief could get there, he was notified that someone logged into the security system and cancelled
  the call for fire he then received a phone call from Erik Depew (the Building Supervisor for VV)
  and asked to come up because the school was full of fog from fire extinguishers.

## **POLICE: Chief Bruner**

- In July, Officers were dispatched to 102 calls for service and took 61 reports. We took:
  - 6 motor vehicle crashes
  - 38 traffic stops were made
  - 8 citations given
  - 33 verbal warnings
  - o 2 arrests
- On August 3, Chief was contacted by Sgt. Jones of German Twp PD in reference to a deceased person located on Ft. Anthony Rd. When Chief arrived on scene, he secured the area and contacted the Montgomery County Sheriff's office (MCSO). MCSO along with Middletown PD were able to make arrests after interviewing two suspects with 48-50 hours after the body was discovered. Both subjects will be in Butler County.
- The 2018 Dodge Charger (old Chief car) did not meet the reserve set at \$7,500 on the first auction and the buyer on the second auction has not paid as of today (sold for \$9,301). If the buyer fails to pay, we will run it a third time.
- Office Update: Chief is currently waiting g on Spectrum, once the phone and internet services are installed/transferred we have an install date of 8/13/2025. Trustee Moyer asked if I would get two quotes on resurfacing the parking lot at the new office. They came back at \$25,015.06 from Butler Asphalt and \$18,275 from Oakley Blacktop. This is for a 2" overlay plus the addition of three public parking spaces with the township prepping the new area. Mr. Moyer made motion to approve the \$18,275 quote from Oakley Blacktop with the General Fund paying for \$10,000 and Mr. DeVilbiss seconded the motion. Motion Passed.

Estimated cost is approximately \$497,863 the Awarding Bid was only \$396,343.23 leaving an approximate amount of \$101,519.77 which we are asking to use on Clayton Rd. from Dayton Farmersville south to Hemple at an approximate cost of \$82,989.26. Mr. Hodson made motion to approve using the additional funds on Clayton Rd. From Dayton Farmersville to Hemple Rd. and Mr. DeVilbiss seconded the motion. Motion passed:
